Use of Beacon	Fire out of control	Injury to workers. Damage to surrounding land and property	Risk Assessment carried out by Norfolk Fire and Rescue service. Conditions agreed by Parish Council	M	Parish Council to be present when beacon is lit and to remain until beacon fire is out. Water and hose on hand during burning period.
