# West Dereham Parish Council

# Minutes of the meeting of the Parish Council held on Thursday 2<sup>nd</sup> March 2023, at 7.00pm, held in the West Dereham Village Hall.

Members of public present: 5 members of the public, Borough Councillor Allan Homes.

# 1. Apologies for Absence.

Apologies were received and accepted from Cllr N. Drew (alternative commitment).

# 2. Declarations of interest.

- 2.1. No pecuniary or non-pecuniary interest were declared on any subject on the agenda.
- 2.2. No dispensation requests were received.

# 3. Minutes.

The minutes of the meeting on Thursday 2<sup>nd</sup> February 2023 were AGREED as a true and correct record and signed by the chairman.

# 4. Updates of items not elsewhere on the agenda.

- 4.1. The Crowdfunder page has been set up for the West Dereham Playground Project.
- 4.2. It was brought to the council's attention that there is a larger letter box on Station Road which can be used to post A4 paper.
- 4.3. The council continues to liaise with Highways with regards to relevant concerns. Highways will be visiting the village in April to review the issues raised.
- 4.4. Hedge trimming around the village has been completed.
- 4.5. Cllr A. Caley and the clerk now have access to Unity Banking.
- 4.6. The Easter extravaganza, to raise funds for the playground project, has been delayed and changed to a village Easter egg hunt with a donation of £2 per child to participate.
- 4.7. If parishioners would like to run for Parish Councillor in the May elections, they can contact the clerk or chair for a nomination paper.

# 5. Open Forum for Public Participation.

- 5.1. Borough Councillor Alan Homes gave a report on the May elections. He informed the meeting that nomination papers must be submitted between March 21<sup>st</sup> and 4:00pm on April 4<sup>th</sup>. The closest hand-in point is at King's Court in Kings Lynn. Nomination papers and guidance on how to complete the forms can be found on the NCC website.
- 5.2. County Councillor Brian Long was not present.
- 5.3. To receive comments from members of the public.
  - 5.3.1. A letter received from Anglian Water with regards to planned water infrastructure work om the boundaries of the Parish was raised along with concerns that water would be cut off. Borough Councillor Allan Homes informed the meeting that this would not be the case.
  - 5.3.2. Reference was made to a correspondence email to the clerk before the Meeting for April. The meeting was informed that this will be included on the

agenda as it had arrived too late to be distributed and included on the agenda

5.3.3. It was raised that advertising in The Village Pump would be of benefit to the community. Councillors agreed to continue using The Village Pump for advertising Parish Council activity, alongside the website, Facebook, targeted leaflet drops and the village noticeboards.
