DRAFT Minutes of the Annual Parish Council Meeting held on Thursday 1st February 2024, at 7.00pm, in the West Dereham Village Hall.

1. Apologies for Absence. Apologies were received and accepted from Cllr A. Challen (alternative commitment).

2. Declarations of interest.

- 2.1. No pecuniary or non-pecuniary interests were declared.
- 2.2. No dispensation requests were received.

The minutes of the meeting on Thursday 7th December 2023 were AGREED as a true and correct record and signed by the chair.

4. Updates of items not elsewhere on the agenda.

- 4.1. The FCC application for funding for the Playground project has been submitted. The Board of Directors will review the application on the 14th March 2024 to decided whether the project will be allocated funding.
- 4.2. The council has submitted an Expression of Interest in receiving funding for cycle storage.
- 4.3. The Playground Working Group will have plans of the playground on display in the village hall on 11th Feb & 3rd March in the afternoon.

- 5.1. A report was received from Borough Councillor Peter Hodson. Cllr Hodson had a meeting with Liz Truss 2 weeks prior who informed him that she has sent letters to the relevant authorities regarding planning application 23/01606/F and has asked to be kept informed.
